Sub: - TSFD - F(C) Act, 1980 - Diversion of 162.457 Ha of forest land in Indaram RF, Mancherial Range of Mancherial Forest Division in Mancherial District for grant of Mining lease for Srirampur Open Cast-II Expansion Project in Jaipur Mandal, Mancherial District in favour of M/s. Singareni Collieries Company Limited, Srirampur Area, Mancherial District - Stage-I approval accorded- Demand Notice issued - Regarding.

1. It is submitted that, the Government of India vide reference 10th cited above has accorded Stage-I approval for diversion of 162.457 Ha. of forest land in Indaram RF, Mancherial Range of Mancherial Forest Division in Mancherial District for grant of Mining lease for Srirampur Open Cast-II Expansion Project at Jaipur Mandal, Mancherial District in favour of M/s. Singareni Collieries Company Limited, Srirampur Area, Mancherial District with conditions stipulated therein which has been communicated by the Principal Chief Conservator of Forests, TS, Hyderabad vide reference 11th cited above with instructions to issue Demand Notice to the User Agency for payment of Compensatory Levies like Net Present Value (NPV) Vegetative Plan and SMC protection barriers, Compensatory Afforestation, Mitigative measures, Restoration of degraded notified forests, Safety zone, Afforestation on degraded forest land one and half time in extent to the area used for Safety zone, Translocation of trees, felling of trees. Demarcation of forest land etc., and also to obtain the compliance report on the conditions stipulated by

the MoEF&CC, Gol, from the user Agency and furnish for onward submission to Government of the Stage-II (final) approval.

- Accordingly, as per the guidelines issued by the Ministry, instructions contained in reference 11th and in compliance to the instructions contained in the reference 18th cited above the Demand Notice prepared is as follows:
 - a. Funds to be deposited into Adhoc CAMPA account of Telangan State through Ministry's portal

The user agency shall compulsorily deposit the NPV, CA and other charges by generating challan through the Ministry's Website.

The following amounts shall be deposited by the User Agency as per the Rules / guidelines issued by the MoEF to deposit all kinds of levies in the respective State CAMPA account only through e-payment method by generating the challan from the Ministry's web portal, in consultation with the Nodal Officer (FCA), O/o. Principal Chief Conservator of Forests, TS, Hyderabad. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at http://parivesh.nic.in.

- a. Further, the User Agency is requested to comply with the conditions contained in the Stage-I approval (.No.4-TSB183/2021-HYD/121, Dt.04.08.2021 communicated vide PCCF, Hyderabad Rc.No.7195/2017/FCA-2, Dt.23.08.2021) the conditions are as detailed below:
- A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department and compliance to be submitted prior to Stage-II approval:

ondition	Condition	Remarks
No. A-ii	From the analysis of the area through DSS it is observed that a river exists on the southern boundary of Srirampur mining lease area that flows through/alongside large forest area on the downstream at some distance of these leases. Therefore, it is essential to protect the water source for the sustainability of flora and fauna there The User agency shall get a detailed plan (comprising of vegetative and SMC protection barriers, and duly approved by the competent authority in the forest department) prepared by an expert agency and implement it to protect the riverbank so that debris, etc. from mines doesn't block or reduce water flow in the river and cause adverse impact on the flora and fauna in the downstream forested area. The plan shall be implemented within 3 years of handing over of proposed forest land to the User Agency;	
A-iii	The area has several coal mines in the vicinity which together had/have been affecting the natural forest cover in this locality in a significant manner, and, therefore, CA over lands other than notified forest would have been ideal scenario. Therefore, keeping in view the goal of harmonious pursual of conservation and development, it was agreed to accept the proposal of Compensatory Afforestation on double the degraded notified forest area under forest department on the condition that in addition to the proposed CA, non-forest area equivalent in size to the diverted forest area shall be made available and mutated in favour of State Forest Department out of the area available immediately after the closure and rehabilitation of mines of M/S SCCL from 2027-28 (or, earlier) onwards as submitted by M/S SCCL vide their letter no.CMD/PS/H/129 dated 29.09.2020. A Board resolution in this regard shall be submitted by the User Agency to the State Forest Department, and the State Forest Department will accordingly ensure the compliance of this condition in a timely manner. The land so mutated shall be notified under the relevant sections of the Forest Act as a Reserve Forest. After handing over, the State Forest Department shall protect the so transferred land and may develop it further at own cost for bringing the area under sustainable forest management. For CA on notified forest land, Nodal Officer shall give a certificate that no afforestation/plantation has been taken up under any plan/programme/scheme on that land in the last ten years;	To be implemente by User agency under the Supervision of the Föres
A-iv A-V	The KML files of diverted area, the CA area and the areas mentioned in sub-clause (ii), (iii) and B(iii) shall be uploaded on e-Green watch portal with all requisite detailsprior to Stage II approval; As reported by DFO, Mancherial Division and endorsed by State Government, the User Agency (M/SSCCL) is having two operational open cast mining projects, namely SRP-1 and RKP OC, 4 underground mines and soon to be operational Indram OC mines. The two operational mines and the Indaram OC will produce about 829 million tons and about 382 million tons of overburden respectively within their lifetime. It is, therefore, crucial to undertake overburden restoration/ stabilisation as the mining progresses asper high scientific to minimise further damage to flora, fauna, soil and hydrology of the adjoining area due to such huge overburden accumulation. As this is a new area of technical expertise, the User Agency has proposed to create adequate capacity in the State Forest Department so that the Eco-restoration of the overburden and the mined out area could be monitored effectively, and for this purpose to expose a team of at least 10 forest officers to global best practice being implemented in coal mines of Australia / New Zealand, etc. at User Agency cost. The recommendation of State Government as reported in the proposal and conveyed by PCCF (HoFF), Telangana and agreed to by the representative of User Agency in the meeting may be accepted on the condition that the visit is approved by the State Government and the admissible expenditure as per norms on this account is reimbursed by the User Agency to the Forest	Departmen

Further, the UA is requested to intimate the details of payments made and submit seven sets of compliance report on all the conditions stipulated in Stage-I approval along with all the necessary documents, certificates, undertaking etc., for onwards submission to the competent authority for issue Stage-II approval.
- c. Further, the User Agency is also requested comply with the following in accordance with the MoEF & CC, GoI instructions issued vide F.No.4-TSB183/2021-HYD/121, Dt.04.08.2021 communicated vide PCCF.. Hyderabad Rc.No. 9917/2017/FCA-1/PS Dt: 18.03.2021.
 - Publish the entire forest clearances granted to the project proponent for the use
 of forest land for the non-forest purpose in verbatim along with the conditions
 and safe-guards imposed by the Central Government in two widely circulated
 daily newspaper i.e., one is vernacular language and the other in English.
 - 2. The copies of the clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.
- d. Further, the user agency shall furnish the copies of Paper Clippings about the publishing of forest clearance etc., as instructed by the Principal Chief Conservator of Forests (HoFF) Telangana, Hyderabad vide reference 2nd cited above.

Therefore, it is kindly requested to the General Manager, M/s SCCL, Srirampur area of Mancherial District intimate the details of payments made and submit the (07) sets of compliance report on the all the conditions stipulated in the Stage-I approval along with Paper clippings about publishing of Forest clearance and all the necessary documents, certificates, Undertaking etc., for taking further action.
