



RE-VERIFICATION REPORT OF CONSTRUCTION OF CHHIAHTLANG &
SERCHHIP BY-PASS ON AIZAWL-TUIPANG SECTION OF NH-54 IN THE
STATE OF MIZORAM

Pursuant to the decision made by the Empowered Committee for Implementation of Central Projects and Programmes vide Memo No.F.260016/1/2022-GAD/PGT Dated 9th.11.2022 (Agenda No-4); re-verification of Chhiahtlang & Serchhip Bypass Road (Package-1) of NH-54 Road Project was conducted on 22nd, November, 2022 for the purpose of reviewing penal NPV due to violation of Forest (Conservation) Act 1980. It was found that the violated area on forest land is 2.43278 Ha.

Further, on careful examination of the date of initial excavation of Chhiahtlang & Serchhip By Pass Road, it was found that the excavation of forest area without IPA at Serchhip By Pass was started during February, 2022 whereas; excavation of Chhiahtlang By Pass (of the same Package) where no forest land was involved started a little earlier. As such, period of violation for the purpose of calculating penal NPV in this particular violation case may be taken as 1(one) year.

The environmental damage area of 9.50 Ha (4.00Ha along Chhiahtlang ByPass + 5.50 Ha along Serchhip Bypass) is outside forest area and therefore may not be included for imposing penal NPV. Mizoram Pollution Control Board (MPCB) is assessing Environmental Compensation (EC) separately for environmental damage due to irregular disposal as decided by State Level Monitoring Committee in its meeting on 25.7.2022.



RE-VERIFICATION REPORT OF AFFECTED FOREST AREA (3.893HA OUT OF 8.9856HA) UNDER PACKAGE -II OF AIZAWL-TUIPANG SECTION OF NH-54 ROAD PROJECT UNDER THENZAWL FOREST DIVISION

Pursuant to the decision made in virtual meeting of officials from Mizoram EF&CC and NHIDCL on 14.12.2022 @ 3.00PM regarding implementation of NH-54 Road project in Mizoram, particularly of Package -II under Thenzawl Division, re-verification of affected forest area (3.893Ha out of total forest area 8.9856Ha) under Package-II of NH-54 Road Project was conducted on 13th, March, 2023 (Monday) at 11.00AM for the purpose of reviewing penal NPV due to non-compliance of provisions under Forest (Conservation) Act 1980. It was found that the violated area on forest land is 3.893 Ha.

Further, on careful examination of the date of initial excavation of forest area in Package -II (3.893Ha) under Thenzawl Division, it was confirmed by both party that the excavation of forest area without IPA was started during November, 2020. As such, the period of violation for the purpose of calculating penal NPV in this particular case shall be taken as 2(two) year.
