महोदय.

उपरोक्त विषय का आशय ग्रहण करने का कष्ट करें। प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक—26.03.2019 द्वारा अतिरिक्त सूचना चाही गयी थी जिसकी अनुपालना प्रधान मुख्य वन संरक्षक एवं वन्यजीव विभाग, नई दिल्ली के उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत की गयी है। प्रस्तुत अनुपालना पर विचारोपरान्त प्रकरण को दिनांक—17. 06.2019 को आहूत की गयी क्षेत्रीय सशक्त समिति (REC) की बैठक में (REC Agenda item 38.4 NCT of Delhi) शामिल किया गया था जिसमें विचारोपरान्त प्रकरण को सशर्त स्वीकृति प्रदान की गयी है,

अतः मुझे मुझे यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार द्वाराका एक्सप्रेसवे (NH-248BB) से किमी० 20, NH-8, से किमी० 40, शिव मूर्ति दिल्ली / हरयाणा बार्डर के निर्माण के लिए 10 है० वन भूमि के प्रत्यावर्तन एवं 2751 वृक्षों (1888 वृक्ष एवं 863 पोल्स) के पातन की सैद्धान्तिक स्वीकृति निम्निलिखन शर्तों पर प्रदान करती है:—

- 1. Compensatory afforestation shall be taken up by the Forest Department over 10 haNon-forest land(as proposed by the Forest Dept.) at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- 2.) The said non-forest land shall be transferred and mutated in favour of the State Forest Department & compliance to this effect shall be submitted alongwith the complete compliance report of conditions imposed in in principle approval.
- 3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

- 4. The State Government shall charge the Net Present Value(NPV) for 10ha. forest area to be diverted@ 8,87000 under this proposal i.e. 8.87000x10 ha.Rs.88,70,000/- from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.
- 5. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 6. The cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 7. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- **8.** All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through *e-portal* (https://parivesh.nic.in/).
- **9.** The compliance report shall be uploaded on *e-portal (https://parivesh.nic.in/)*.

The proposal was submitted vide letter no. 158/WFD/COT/17-18/Package-1/2213-15,DT.13.03.2019 from Conservator of Forests, Department of Forest& Wildlife IP Estate New Delhi Government NCT New Delhi. Some queries raised by this office vide letter no. 8B/DLI/06/02/2019/FC/682dated 26.03.2019& 29.03.2019. The PCCF & Nodal Officer, FCA vide their letter No.158/WFD/COT/17-18/Package-1/3418-20 dated 07.05.2019 has submitted the reply of the above queries. Again clarifications were sought vide letters dated 28.05.2019 & 30.05.2019 regarding CA and NEW calculation representative. NPV calculation respectively.

The details of the proposals are as under:

The proposal was submitted vide no. 158/ WFD/COT/17-18/Package-1/2213-15,DT.13.03.2019 from Conservator of Forests, Department of Forests Wildlife IP Estate New Delhi Government NCT New Delhi has been signed and recommended by the all concerned authorities in the part I, II, III, IV & V. No specific comments, regarding the proposal have been made in Part II, III, IV and V and recommendation has been made emphasising the vital importance and necessary in large public interest.
Site inspection reports on page-no.31-31of Proposal filled by the concerned DCF having territorial jurisdiction on proposed forest natchessar per page no.31-32 Violetion of Forests.

on proposed forest patches-as per page-no. 31-32Violation of Forests (Conservation) Act-1980 has not been

reported (Site inspection report at page no. 31-32).

3. As per part II of the proposal the proposed forest patch is not a part of any Bird sanctuary National Park, or Wild life sanctuary. The project isfor construction and Development of Dwarka Express Way (N-248BB) from km.20,NH-8(near Shiv Murti,Delhi) to km 40, NH-8(near village Khirki Dola,Gurgram) in the NCT of Delhi-Package-I Shiv Murti to Delhi/Haryana Border(km 0.00 to km.5.300) 10 ha.Deemed forest land with felling of 1888 trees and 863 Poles Toatal 2751 Treesfor Dwarka Express Way.

4. As per part II of the proposal; the proposed forest patches are not located in the area having protected archaeological / heritage site / defence establishment or any other important monument and no rare/endangered/unique species of flora and fauna found in the area.
