- 1. It is Submitted that the Government of Telangana vide ref 5th cited has issued Principle (Stage-I) approval for diversion of 0.4768 Ha of Forest land in Narsampet Range in Warangal Rural District for laying of optical fiber cable in favour of M/s Telangana Fiber Grid Corporation Limited Hyderabad and the same is communicated by the vide reference 6th cited by the Principal Chief Conservator of Forest (HOFF) Telangana and instructed to raise the Demand Notice over the user agency for making payment of compensatory levies; obtain the compliance report from the user agency and furnish through CCF Warangal for obtaining stage-II final approval.
- 2. Accordingly the following compensatory Levies are prepared.

Through online mode only, through e-portal method at MoEF & CC, GOI New Delhi portal i.e; http;//parivesh.nic.in by generating the challan in consultation with Nodal Officer Telangana State Forest Department. The user agency needs to upload the Demand Notice against the Project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. 3.Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

- a) Publish the entire forest clearances granted in verbatim along with the condition and safeguards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- b) The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.
- 4. Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage-I approval for onward submission to Government for obtaining Stage-II approval.
- The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

As per the instructions issued by the Principal Chief Conservator of Forest (FCA) Telangana Hyderabad and CCF Warangal draft demand notice is issued to the user agency for vetting.
