In view of the above, the User Agency is requested to deposit the compensatory levies towards CA, NPV etc. into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account through online mode only, through e-portal method at MoEF & CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>

Further, the User Agency is requested to comply with the following in accordance with the instructions issued by the GOI, MoEF&CC, New Delhi vide F.No.7-23/2012-FC, dt:24.07.2013 communicated vide PCCF's Rc.No.45921/2001-F4, dated:23.08.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearance granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English granted to the project proponent for use of forest land for non-forest purposes.
2. The copies of the Forest Clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days..

Further, the user agency is requested to furnish compliance report along with all the required relevant information/documents etc., as stipulated in Stage-I approval and other conditions at the earliest, so as to submit the condition wise compliance report to the higher authorities for obtaining Stage-II approval. The User Agency is informed that the transfer of forest land to User Agency shall not be affected prior to the issue of final approval of Stage-II clearance(or) working permission whichever is earlier and no work in violation shall be carried out.
