With reference to above, this is to inform you that the Site Specific Wildlife Conservation Plan for the above said project has been approved by the PCCF (WL) & CWLW, Odisha with financial forecast of ₹ 104.34 Lakhs (Bonai Division-21.60 Lakh + Rourkela Division-82.74 Lakhs) for the activities to be implemented by Bonai Division and Keonjhar Division. So, you are requested to deposit of ₹21.60 Lakhs only in respect of Bonai Division through e-portal of MoEF & CC as provided in the http://parivesh.nic.in, and submit the original proof with seal and signature of the issuing Bank to this office for needful.
