With reference to the letter nos. cited above on the captioned subject, it is to inform you that, a sum of Rs. 3,32,81,613.00/- (Rupees Three Crore thirty two lakh eighty one thousand six hundred thirteen) only was demand towards revised Compensatory Afforestation Scheme prepared as per the based on one time cost norm for the year 2024-25 against the proposal for diversion of 32.225 ha. of forest land (diversion of 17.795 ha of Forest land + re-diversion of already diverted 14.43 ha) for Bahargoda to Singhara Section of NH-6 for Rehabilitation & Upgradation to four laning of 7.6 KM stretch (KM 229.00 to Km 236.600) inside buffer zone of Similipal Tiger Reserve as per Conditions No. A(ii) stipulated in Stage -I / Principle Approval Letter No. 5-ORC597 / 2023 - BHU dt.31.10.2023 of Dy.
