Demand Notice for differential CA & other charges

Sub: Diversion of 5.271 hectares of forest land for existing / proposed approach road Downhill Pipe Conveyor (DPC) and service road, Transmission line cable and Water pipeline in Swamymalai (SM) Block Forest, Lakshmipura Village, Sandur Taluk, Ballari District in respect of Devdhari Iron Ore Mine (ML No.2290) in favour of M/s. JSW Steel Ltd, Ballari District.

With reference to the above subject, the Government of India and Government of Karnataka have accorded Stage-II approval for Diversion of 5.271 hectares of forest land for existing / proposed approach road Downhill Pipe Conveyor (DPC) and service road, Transmission line cable and Water pipeline in Swamymalai (SM) Block Forest, Lakshmipura Village, Sandur Taluk, Ballari District in respect of Devdhari Iron Ore Mine (ML No.2290) in favour of M/s. JSW Steel Ltd, Ballari District vide letters under Ref (1) & (2).

In pursuance of the same, the Principal Chief Conservator of Forests (Forests Conservation) & Nodal Officer(FCA), Bengaluru has directed the undersigned to execute an agreement with User Agency duly incorporating all the terms and conditions as imposed by the Government of India and Government of Karnataka and standard conditions applicable to FC leases from time to time and further subject to payment of any recoverable balance in compliance of the conditions of Stage-I & Stage-II (final) approvals vide letter under Ref(3). in pursuance of the Stage-I approval, the office of the undersigned has issued demand notice vide letter under Ref(4). In this regard, you have remitted the NPV & other charges.

Further to this, there is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) in the year 2022-23] notified vide letter under Ref(5). The differential CA charges as applicable for the above referred proposal are calculated as here under;

After acceptance by the Nodal Officer, a Challan should be generated from the web portal for payment to the account mentioned in the Challan and submit the original remittance challan to this office for further action.

Further, it is requested to submit the following documents and undertaking for execution of agreement as per above directions.

- 1) Documents related to authorized signatory viz., power of attorney if any.
- 2) Undertakings for condition stipulated in Government of India and Government of Karnataka.
