A separate proforma proposal has submitted to Standing Committee of National Board for Wildlife, New Delhi, for according their approval.

I, therefore, request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section-2 of Forest (Conservation) Act, 1980, subject to imposing conditions stipulated by Principal Chief Conservator of Forests (WL) & Chief Wildlife Warden, Telangana State, Hyderabad at the earliest.


