17.836 ha. of non forest land out of total area of 18.0000 ha. pertaining to plot No.214/620 in village –Benidihi has been identified for raising compensatory afforestation in lieu of diversion of forest land in respect of Utility corridor of Khondbond Project of M/s Tata steel Ltd. as per request made by Ganesh Prasad Sahu, Constituted Attorney, head Ferro alloys Production Ferro Alloys & Minerals Division), Tata Steel Ltd. vide his letter No.JCO/13/46/116 dt.6.3.2019(copy enclosed)
