No. 3/1/2020-DC/CCP/21: In compliance of the Ministry of Environment and Forest (MoEF) Government of India's letter No 11-9/98-FC (pt) dated 3rd August, 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribe and Other traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 1.6223 hectares of forest land proposed to be diverted in favour of the Directorate of Health Services, Manipur, for the project, namely "**Proposed Construction of Churachandpur Medical College (100 Admissions) at Mata Village, District Churachandpur (Manipur).**" at Mata Village does not fall within any **Reserved Forest/Protected Forest of Manipur** nor **National Parks or Wild Life Sanctuaries.**

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 10.12 Ha (inclusive of 1.6223 Ha actual forest area) of **shrub vegetation area** proposed for the diversion;
- (b) There is no forest dwelling Scheduled Tribe and Other Traditional Forest Dweller in the entire 10.12 Ha of forest land at Mata Village proposed for diversion by the **Directorate of Health Services, Manipur.**
- (c) The proposed diversion does not affect the recognised rights of Forest Dwelling Scheduled Tribes, Other Traditional Forest Dwellers, Primitive Tribal Groups ad Pre-agricultural Communities as the proposed area is not inhabited;
- (d) The forest land proposed for diversion by the **Directorate of Health Services, Manipur** is located at Mata Village and lies within the jurisdiction of the **Mata Village.**

(f) **Mr. Vungzamuan Valte** has given his consent to the proposal for diversion of shrub vegetation land for " **Proposed Construction of Churachandpur Medical College (100 Admissions) at Mata Village, District Churachandpur (Manipur)**." Presented for Registration at 14:00 hrs the 16th day of March 2020 at Churachandpur Registration Office by the Govt. of Manipur (Director of Health Services), the executive or Claiment SDO at SR/CCP of Tehsil CCP', under Registration of Gift Deed No. 105/2020, dated 16th March 2020.

A copy of the **Gift Deed of the Mr. Vungzamuan Valte** in its conveyance dated the 27th January 2020, is enclosed for reference.

(This certificate has been issued with appropriate modifications to the format prescribed by the Ministry of Forest and Environment, Government of India vide its letter no. F. No 11-9/98-FC (pt) dated 05.07.2013 in view of the non existence of habitation and interests in the area proposed to be diverted.)
