


The Conservator of Forests/District Forest Officer, R.R District has requested the District Collector for issue certificate in Annexure – I (Form-I) for diversion of 0.0286 HA of Forest land in Gungal Reserve Forest Sy.No.10 of Amangal Division for formation of approach road to reach the agricultural lands in favour of A. Praveen Reddy and others, Hasthinapuram, Hyderabad.

Accordingly the Members of Gram Panchayath, Gungal village Yacharam Mandal have passed resolution on 03.05.2021 declaring to issue No Objection for diversion of 0.0286 HA of forest land in Gungal RI of Amangal Division for formation of approach road to reach the Agricultural lands in favour of A.
