Demand Notice for differential CA & other charges

With reference to the above subject, the Ministry of Environment Forests and Climate Change, Government of India has sought certain information vide letter under Ref(1). In this regard, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has directed the undersigned to submit information / documents as sought by the Government of India.


Further, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has directed the undersigned to issue additional Demand Notice to the User Agency for recovering the CA difference amount on account of revision of CA rates with effect from 01.05.2020 and to take similar action in respect of Condition No. (xxvii) regarding the present rates for raising Avenue Plantation vide letter Dt.25/26.06.2020 under Ref(2).

There is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) in the year 2020-21] notified vide letter under reference (4). The differential CA charges as applicable for the above referred proposal are calculated as here under;
