In compliance of the Ministry of Environment & Forest (MoEF), Government of India's letter No 11-9/98-FC dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Schedule Tribes and Other Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non forest purpose read with MoEF's letter dated 5<sup>th</sup> Feb 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 4.0122 ha. of forest land proposed to be diverted in favour of Navi Mumbai Municipal Corporation for Construction of Ghanasoli to Airoli Creek Bridge in Thane district falls within jurisdiction of Ghanasoli, Talwadi and Dive, Village in Thane Tehsil.

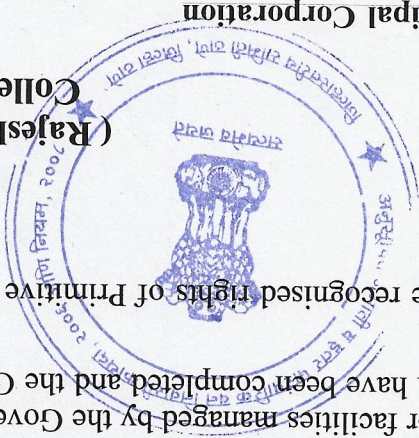
