It is to inform you that, there is a requirement of about 0.985 ha. of forest land in Ranibahal village under Jayapatna Tahasil of Kalahandi district for which we shall submit Forest Diversion Proposal to MoEF & CC, Govt. of India through Proper Channel.

It is mandatory to submit the required certificate under FRA 2006 (i.e. the schedule tribes and other traditional Forest Dwellers –recognition of Forest rights) from your good self along with the Forest Diversion proposal in pursuance to MoEF Letter No. 11-9/98-FC (pt.) dt.03.08.2009 (Copy enclosed).

Therefore, Its requested to issue required in Form-II of MoEF guideline issued vide F. No. 5-2/2017 FC dt.28.03.2019 (Copy enclosed) for submission of evidences for having initiated and completed the process of settlement of Rights under the schedule tribes and other traditional forest dwellers (Recognition of Forest Rights) Act, 2006 on the forest land proposed to be diverted for Non- Forest purposes.

The proposed site is un-surveyed revenue land having forest raised under plantation mode. We enclosed the cadastral sheet showing our project area jointly verified by DFO, Kalahandi South Division & Tahasildar, Jayapatna for your kind reference.

Therefore, you are requested to kindly issue necessary certificate as per the format enclosed after maintaining required formalities.
