I am directed to enclose a copy of the references first and third cited and to state that, the Principal Chief Conservator of Forests (Head of Forest Force) in his letter first cited has stated that, the Project Director, National Highways Authority of India, PIU-Kancheepuram, Guindy, Chennai has uploaded online forest clearance proposal under section 2 of Forest (Conservation) Act, 1980 for diversion of 14.029 ha of forest land in Tiruvallur Forest Division for construction of six lane highways green field corridor from Chittoor to Thatchur road (NH 716B) lies in 3.4186 ha of area in Thirumalairajupettai Reserved Forest and 10.6103 ha of forest area in Nediya Reserved Forest of Tiruvallur District.

2. In the Part-II of Form A, the District Forest Officer, Tiruvallur Division has furnished the following details:-

- i. The legal status of the proposed site of diversion of 14.029 ha of forest land requested for the project is Reserved Forests. As per the site inspection report, Thirumalarajupettai Reserved Forest and Nediya Reserved Forest areas are involved in the project.
- ii. Density of the forest area is 0.4 and Eco class of forest area is four.
- iii. Details of species wise and girth class wise enumeration of trees in the area and 1783 number of trees enumerated in the proposed forest diversion area. Out of 1783 number of trees, 264 number of trees are spontaneous and all the 1783 number of trees including thorny bushes are to be removed for this project. As per section 4(ii) of Part-II, there are 1783 Nos. of trees, among which 205 Neem trees, 46 Kattu vagai trees, 3 Tamarind trees, 19 Neer Marutham trees, 3 Ilanthai trees, 26 Veppalai trees, 12 Pungan trees, 473 Velvel trees, 618 Perumbai trees, 1 Banyan tree, 3 Aya trees, 336 Naval trees, 8 Ilupai trees, 17 Achan trees, 4 Teak trees, 8 Porasu trees and 1 Alinji tree.
- iv. On the Brief note on vulnerability of the forest area to erosion, the District Forest Officer has reported that no vulnerability to erosion.
- v. Wild pig, Monitor lizard, hares, Deer are present in and around the forest land proposed for diversion. The forest area proposed for diversion is not part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant corridor, Wildlife migration corridor etc., and not located within the eco-sensitive zone of the protected area notified under the Wildlife (Protection) Act, 1972 and not located within 1 km boundary of NP/WLS etc., for the forest land proposed for diversion. There is no rare/ endangered / unique species of flora and fauna found in the area.
- vi. There is no protected archaeological / heritage site / defense establishment or any other important monument is located in the area.
- vii. Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project and no work in violation of the Act or guidelines has been carried out.
- viii. For the diversion of 14.029 ha of forest land, the District Forest Officer has proposed the compensatory afforestation scheme work in the following degraded forest areas:-
  - a. For the diversion of 14.029 ha of forest area, revised compensatory afforestation scheme including to carry out soil conservation work, protection of plantation etc., has been proposed in 28.0 ha of effective area comprising 10.45 ha area in Mylarwada RF, 7.12 ha in Konasamuthiram Extension Reserved Forest and 10.488 ha area in Konasamuthiram Reserved Forest with a financial out lay of Rs.5,93,51,282/- with the following item of works:-

- b. In the compensatory afforestation scheme, provision has been made for plantation protection measures like creation and maintenance of fire lines and removal of lemon grass in the identified degraded forest area of compensatory afforestation scheme site apart from providing water harvesting structures based on site needs.
- ix. In the site inspection report, the District Forest Officer, Tiruvallur Division has stated that, the proposed project site in Thirumalarajupettai Reserved Forest and Nediya Reserved Forest was inspected on 09.03.2022. The forest type of southern tropical dry mixed deciduous forest is distributed in the Reserved Forests. The density class is moderately dense with eco-class-IV. Wild animals like Spotted deer, Wild boar, Python, porcupine, Mongoose, Peacock, Monitor lizard, and Snakes etc., are said to be present in the forest.
- x. In the specific recommendation of the proposal, the District Forest Officer, Tiruvallur Division has reported that the proposed forest land diversion for carrying out the six lane highways green field corridor involves forest area to an extent of 3.4186 ha in Thirumalarajupettai Reserved Forest and an extent of 10.6103 ha in Nediya Reserved Forest. The proposed diversion of forest land does not lie in the protected area. The proposed site is situated about 60 km away from the Pulicat Wildlife Sanctuary. The diversion of the forest land is found to be bare minimum area. Considering the above views, diversion of 14.0289 ha area recommended subject to the fulfillment of condition that full-fledged chain link fencing shall be erected on either side of the road to prevent further biotic interference at the cost of user agency.

3. The Conservator of Forests, Chennai Circle has inspected the area on 08.07.2022 and has endorsed the facts and views furnished by the District Forest Officer, Tiruvallur Division and forwarded the proposal with her recommendation.

4. The User Agency has requested forest area diversion for a period of 99 years. The District Forest Officer, Tiruvallur Division has recommended the proposal for a period of 25 years and the Conservator of Forests, Chennai Circle has recommended the forest area diversion for a period of 20 years. Based on the recommendations made by the Conservator of Forests, the Principal Chief Conservator of Forests (Head of Forest Force) has recommended diversion of forest area for the project proposal for a period of 20 years.

5. The Principal Chief Conservator of Forests (Head of Forest Force) further stated that, the proposal is sent duly recommended by the Additional Principal Chief

Conservator of Forests (Forest Conservation Act) / Nodal Officer of Forest (Conservation) Act, 1980 of the State of Tamil Nadu.

6. Based on the recommendation made by the District Forest Officer, Tiruvallur Division and Conservator of Forests, Chennai Circle, the Principal Chief Conservator of Forests has recommended the proposal for diversion of 14.029 ha of forest land in Tiruvallur Forest Division for construction of six lane highways green field corridor from Chittoor to Thatchur road (NH 716B) lies in 3.4186 ha in Thirumalairajupettai Reserve Forest and 10.6103 ha in Nediya Reserve Forest of Tiruvallur District in favour of the Project Director, National Highways Authority of India, PIU-Kancheepuram, Chennai under section 2 of Forest (Conservation) Act, 1980 for a period of 20 years and requested the Government to forward same to Government of India for obtaining the approval for the project proposal, subject to the following conditions:-

- i). The legal status of the diverted forest land remains unchanged.
- ii). The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.
- iii). The User Agency has to pay the cost of Raising Compensatory Afforestation / Maintenance of plantation, protection of plantation etc., as fixed by the Forest Department and willingness to deposit additional amount if any suggested as amended owing to the change in planting technique, enhancement in the FSR etc., demanded subsequently.
- iv). The User Agency has to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.
- v). The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.
- vi). Amount of Compensatory levies, Net Present Value of forest area under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>)
- vii). Full fledged chain link fencing shall be erected on either side of the road to prevent further biotic interference at the cost of User Agency and responsibility lies with the User Agency for its further maintenance during the project diversion period.
- viii). The User Agency has to obtain orders from the Hon'ble Supreme Court of India for felling of 264 number of spontaneous trees to be felled in the project proposal area.
- ix). The User Agency has to pay the cost towards felling and transportation cost of trees to be cut in the project area (1783 numbers) to the District Forest Officer, Tiruvallur Division for immediate execution of the felling of trees work after getting necessary permission for felling of trees.
- x). The User Agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire

project period as the forest area diversion is meant for commercial activity usage.

- xi). The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies / department or person without prior approval of State Government.
- xii). Violation of any of these conditions will amount to violations of Forest (Conservation) Act, 1980 and action would be taken as per rules in force.
- xiii). Any other conditions that the Ministry of Environment, Forests and Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forests and wildlife.
- xiv). The total forest area utilized for the project shall not exceed 14.029 ha
- xv). Period of lease is twenty (20) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.

7. On further clarification, with regard to the applicability of Forest (Conservation) Rules, 2022, the Principal Chief Conservator of Forests has reported that, the proposal was already accepted by the Nodal Officer and proposal was forwarded to the District Forest Officer, Tiruvallur Division on 30.07.2021 ie., before coming into effect of Forest (Conservation) Rules 2022, for further processing the proposal under Forest (Conservation) Act, 1980. The District Forest Officer, Tiruvallur Division has uploaded his recommendation of the Project on 01.06.2022. The Conservator of Forests, Chennai Circle has forwarded the proposal on 15.07.2022. Parivesh web portal has also accepted the uploading of the recommendations of the Nodal Officer and the proposal was forwarded by the Principal Chief Conservator of Forests (Head of Forest Force) Chennai to the Government vide letter dated 21.10.2022 and uploaded in the web portal on 21.10.2022. As the above project was accepted by Nodal Officer and forwarded to the District Forest Officer way back in 30.07.2021, the provisions of Forest (Conservation) Rules, 2022 (Project Screening Committee Recommendation) is not applicable in this case.

8. Further, he has furnished the original certificate issued by the District Collector, Tiruvallur District furnished by the User Agency. The User Agency has also uploaded the above certificate in section K of Part -I of Form-A and in the additional details information section. Hence, he has requested the Government to consider the subject proposal and obtain Government of India's approval.

9. The Government have examined and accept the proposal (FP/TN/Road/ 53276/2020) of the Principal Chief Conservator of Forests (Head of Forest Force) for diversion of 14.029 ha of forest land in Tiruvallur Forest Division for construction of six lane highways green field corridor from Chittoor to Thatchur road (NH 716B) lies in 3.4186 ha in Thirumalairajupettai Reserve Forest and 10.6103 ha in Nediya Reserve Forest of Tiruvallur District in favour of the Project Director, National Highways Authority of India, PIU-Kancheepuram, Guindy, Chennai, for a period of 20 years, under section 2 of Forest (Conservation) Act, 1980 and decided to forward the same to Ministry of Environment, Forests and Climate Change, Government of India for obtaining their concurrence.

10. I am, therefore, directed to request you to kindly obtain the concurrence of the Competent Authority and communicate the same to this Government, early.

1) I wish to state that the Project Director, National Highways Authority of India, PIU-Kancheepuram, Guindy Chennai has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 14.029 ha of forest land in Tiruvallur Forest Division for construction of six lane highways green field corridor from Chittoor to Thatchur road (NH 716B) lies in 3.4186 ha of

area in Thirumalairajupettai RF and 10.6103 ha of forest area in Nediya RF of Tiruvallur District under proposal No. FP/TN/Road/53276/2020.

2) Details of forest area diversion proposed by the User agency and proposal forwarded by the District Forest Officer and Conservator of Forests for the project is briefed below.

i) The User Agency has uploaded the proposal in the prescribed format of Form A - Part I - under Section 2 of the Forest (Conservation) Act, 1980 for diversion of fresh forest area.

ii) Name of the project in which forest land required and short narrative of the project reported as, construction of 6 lane highway Greenfield corridor from Chittoor to Thatchur road (NH 716B).

iii) The User Agency has reported that area required in forest area is for 14.029 ha., and non forest land required for the project is 294.7696 ha.,

iv) The User Agency has proposed the forest area diversion for the project for a period of 99 years. The legal status of the User Agency is Central Government.

v) In the section of uploading details of proposal seeking prior approval of Central Government under the Act for diversion of forest land for the project already submitted in the past reported as NIL

vi) Diversion of 14.029 ha of forest has been requested in Tiruvallur Forest Division area in Tiruvallur District.

vii) In the village wise breakup, the user agency has reported the forest area requirements as follows.

x) Note containing justification for locating the project in forest area has been uploaded. The User Agency has uploaded a copy of alternative examined for the project.

xi) The User Agency has stated that this project is likely to generate permanent/regular employment for 100 persons and temporary employment for 2000 persons. The User Agency has stated that this project does not involve displacement of people due to the project. The User Agency has stated that cost-benefit analysis for the project is not required.

xii) The user agency has reported that environmental clearance has been issued by the MoEF&CC on 28.12.2020 and no CRZ clearance is required for the project

xiii) The User Agency has stated that the project or part thereof is not located in any protected area or their Eco sensitive zone. The User Agency has stated that this project or a part thereof is not located in a Scheduled area.

a) For the diversion of 14.029 ha of forest area, revised compensatory afforestation scheme including to carry out soil conservation work, protection of plantation etc., has been proposed in 28.0 ha of effective area comprising 10.45 ha area in Mylarwada RF, 7.12 ha in Konasamuthiram Extension RF and 10.488 ha area in Konasamuthiram RF with a financial out lay of Rs. 5,93,51,282/- with the following item of works.

b) In the compensatory afforestation scheme, provision has been made for plantation protection measures like creation and maintenance of fire lines and removal of lemon grass in the identified degraded forest area of compensatory afforestation scheme site apart from providing water harvesting structures based on site needs.

ix) In the site inspection report, the District Forest Officer, Tiruvallur Division has stated that, the proposed project site in Thirumalarajupettai RF and Nediya RF was inspected on 09.03.2022. The forest type of southern tropical dry mixed deciduous forest is distributed in the Reserved Forests. The density class is moderately dense with eco-class-IV. Wild animals like Spotted deer, Wild boar, Python, porcupine, Mongoose, Peacock, Monitor lizard, and Snakes etc., are said to be present in the forest.

x) In the specific recommendation of the proposal, the District Forest Officer, Tiruvallur Division has reported that the proposed forest land diversion for carrying out the six lane highways green field corridor involves forest area to an extent of 3.4186 ha in Thirumalarajupettai RF and an extent of 10.6103 ha in Nediyaam RF. The proposed diversion of forest land does not lie in the protected area. The proposed site is situated about 60 km away from the Pulicat Wildlife Sanctuary. The diversion of the forest land is found to be bare minimum area. Considering the above views, diversion of 14.0289 ha area recommended subject to the fulfillment of condition that full-fledged chain link fencing shall be erected on either side of the road to prevent further biotic interference at the cost of user agency.

4) The Conservator of Forests, Chennai Circle has inspected the area on 08.07.2022 and has endorsed the facts and views furnished by the District Forest Officer, Tiruvallur Division and forwarded the proposal with her recommendation.

5) The User Agency has requested forest area diversion for a period of 99 years. The District Forest Officer, Tiruvallur Hosur Division has recommended the proposal for a period of 25 years and the Conservator of Forests, Chennai Circle has recommended the forest area diversion for a period of 20 years.

Based on the recommendations made by the Conservator of Forests, diversion of forest area for the project proposal is recommended for a period of 20 years.

6) As recommended by the District Forest Officer, Tiruvallur Division and Conservator of Forests, Chennai Circle, the proposal of diversion of 14.029 ha of forest land in Tiruvallur Forest Division for the construction of six lane highways green field corridor from Chittoor to Thatchur road (NH 716B) lies in 3.4186 ha of area in Thirumalairajupettai RF and 10.6103 ha of forest area in Nediyaam RF of Tiruvallur District in favour of Project Director, National Highways Authority of India, PIU-Kancheepuram, Chennai is recommended subject to the following conditions.

i) The legal status of the diverted forest land remains unchanged.

ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.

iii) The User Agency has to pay the cost of Raising Compensatory Afforestation / Maintenance of plantation, protection of plantation etc., as fixed by the Forest Department and willingness to deposit additional amounts if any suggested as amended owing to the change in planting technique, enhancement in the FSR etc., demanded subsequently.

iv) The User Agency has to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.

v) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.

vi) Amount of Compensatory levies, Net Present Value of forest area under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>)

vii) Full fledged chain link fencing shall be erected on either side of the road to prevent further biotic interference at the cost of user agency and responsibility lies with the user agency for its further maintenance during the project diversion period.

viii) The user agency has to obtain orders from the Hon'ble Supreme Court of India for felling of 264 number of spontaneous trees to be felled in the project proposal area.

ix) The user agency has to pay the cost towards felling and transportation cost of trees to be cut in the project area (1783 numbers) to the District Forest Officer, Tiruvallur Division for immediate execution of the felling of trees work after getting necessary permission for felling of trees.

x) The User Agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period as the forest area diversion is meant for commercial activity usage.

xi) The forest land proposed to be diverted shall under any circumstances be transferred to any other agencies/ department or person without prior approval of State Government.

xii) Violation of any of these conditions will amount to violations of Forest (Conservation) Act, 1980 and action would be taken as per rules in force.

xiii) Any other conditions that the Ministry of Environment, Forests and Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forests and wildlife.

xiv) The total forest area utilized for the project shall not exceeds 14.029 ha


xv) Period of lease can be twenty (20) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.


