The OFC cable will be laid by digging trench of size 0.45 mt. wide and depth below 1.40mt. & in one trench two duct pipe will be laid, & out of which one duct pipe is use for OFC cable. After laying of pipe the trench will be refilled. In this work there is no need to cutting of trees for this work.

Project authority submits that, cost of C.A. may not be levied in this proposal as the proposed laying of OFC cable within Row of existing road, road passing outside National Park & WL.
