 - (ii) Nizgarh RF – 1.651 ha,
- 2- **Eco Value Class**
 - (i) 62.443 ha. – ECO Value Class I with canopy density = above 0.7.
 - (ii) 1.651 ha. – ECO Value Class III with canopy density = below 0.4
- 3- **Rate per ha. towards NPV**
