Diversion of 1.912 Ha. of forest land within the jurisdiction of Cuttack Forest Division of Jajpur District, Odisha for up gradation of road from RD 1/966 Km. to 5/00 Km (RD Road to Aradapal) over a length of 3.034 Km through forest area out of total road length of 5.0 Km. by Executive Engineer, Rural Works Division, Jajpur, Odisha under ADB assisted PMGSY vide Package No. OR-13-ADB-15/Tr-III (Proposal No. FP/OR/ROAD/28940/ 2017)

Sir,

With reference to the letter cited above on the captioned subject, it is to inform that the F&E Deptt., Govt. of Odisha vide letter under reference have accorded permission for up gradation of road from RD 1/966 Km. to 5/00 Km (RD Road to Aradapal) over a length of 3.034 Km through forest area out of total road length of 5.0 Km. by Executive Engineer, Rural Works Division, Jajpur, Odisha subject to fulfillment of 15 nos of conditions.

In this connection, for compliance of Condition No.5, it is requested to pay the Net Present Value (NPV) of forest area proposed to be diverted under the proposal as per the orders of Hon'ble Supreme Court of India dt.28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1195 and the Guidelines issued vide letter No.5-3/2007-FC dt.05.02.2009 in this regard. The NPV amount is calculated below:-

- (i) The forest area proposed for diversion 1.912 Ha.
- (ii) Eco-value class-III, density of vegetation below 0.4
- (iii) The NPV to be paid @ Rs.6,26,000/- per Ha.=1.912 Ha.X 6,26,000/-= Rs.11,96,912/-

(Rupees Eleven lakh Ninety Six thousand Nine hundred Twelve) only.

Hence, it is requested to furnish an Undertaking to pay the additional amount of NPV if so determined as per final decision of the Hon'ble Supreme Court of India. So, you are requested to make arrangement for payment of the above amount through **e-payment module** and submit the receipt of the deposition as evidence with UTR No. & date to this office for reference and record.
