Sub:- Revised compensatory afforestation scheme (as per plantation under Delhi preservation of tree act, 1994) for the diversion proposal of 13.5165 ha. forest land for the construction of LILO of both circuit of 400kV Bawana-Mandola Transmission line at Maharani Bagh by Power Grid Corporation of India limited.

1. A compensatory afforestation of 13516 sapling has to be carried out over an area of 13.5165 ha. land located at the following mentioned locations
 - a. Area measuring (2.44 ha.) near Shastri Park Metro Station adjoining to Yudhister Setu on Easter Bank of River Yamuna. (Vide DDA land allotment letter dated 03.01.2020).
 - b. Area measuring (2.26) ha. land near Usmanpur village adjoining to Yudhister Setu on Easter Bank of River Yamuna. (Vide DDA land allotment letter dated 03.01.2020).
 - c. Area measuring 5.3 ha near Garhi Mandu forest vide DDA land allotment letter dated 15.01.2021.
 - d. Area measuring 4.3 ha. located at in opp. of Kashmere Gate ISBT flyover near Muni ki Kuti (vide DDA land allotment letter dated 15.01.2021).
2. As per existing norms of Compensatory Plantation in department of Forest and wildlife, GNCTD, the cost of plantation and 07 years maintenance is Rs 5700/- (five thousand Seven Hundred only) per sapling.*
3. As per the existing ratio, 1000 sapling can be planted in 01 hectare. Therefore, 13516 saplings are to be planted in 13.5165 ha. land.
4. For per sapling cost/expenditure for 10 years is $(5700/7 \times 10) = \text{Rs. } 8142.86/-$
5. The Estimate therefore is $8143 \times 13516 = \text{Rs. } 11,00,60,788/-$ (Rupees Eleven Crore Sixty Thousand Seven Hundred Eighty Eight Only) for 10 years.

The component of plantation activity are as follows:

S. No.	Component of work
1	Fencing.
2	Removal of dead wood and dry bushes and malba, etc. and leveling .
3	Uprooting of root stumps, weeds etc. and site preparation with good earth.
4	Mechanical digging of pits.
5	Application of Chloro-pyro-phos and gypsum for termite/laterite treatment etc.
6	Flooding the pit with water.
7	Treatment of pits with FYM.
8	Cost of sapling..
9	Transportation cost of sapling from nursery to site.
10	Irrigation during months of planting and remaining months of Ten years of creation of plantation.
11	FYM/Neem cake, bone meal and insecticide for 10 years
12	Casualty replacement in 2 nd & 3 rd years for 20% of the plantation.
13.	Watch and ward duty including monitoring and evaluation.
14	Total estimated cost for creation and maintenance including fencing.

6. The said amount includes administrative & contingency charges @ Rs. 1000/- (Rupees One Thousand Only) per sapling for 10 years.
7. The payment at pt. 4 shall be deposited to CAMPA fund only through e portal.
