DETAILED JUSTIFICATION NOTE

Justification for locating the project in Forest land and details of alternative examined

- 1) The project (Ordinary building Stone quarry in forest sy no.61 of Khurse village Sampakhanda Hobli Sirsi Taluk Uttara Kannada) is intended to supply building stones required as raw material for Shri Nidhi Stone Crusher Manjuguni to produce aggregate jelly. The Shri Nidhi Stone Crusher is established in Manjuguni Village malki sy no.52/2. The Stone crusher is complied all measures by KSPCB (Karnataka State Pollution Control Board). It has obtained CFO (Consent For Operation) there is always high requirement for various sizes of crushed jelly in construction activities like State highway Projects, major district roads, Check dams Village roads, agricultural ware houses, Cement brick industries, Cement concrete products and many developmental works in and around Sirsi taluk. This project (Ordinary Building Stone Quarry) is the nearest raw material source for Shri Nidhi Stone Crusher and other civil contractors.
- 2) We have examined various alternatives for this project as detailed below
- a) Alternative 01: We have identified availability of building stones in malki sy no.02 of Manjuguni village Sampakhanda Hobli Sirsi Taluk Uttara Kannada. But after conducting detailed survey it was found that some agricultural establishment, cattle Sheds for dairy, residential buildings and also temples are located nearby location and hence this location could not be selected.
- **b)**Alternative **02**: Malki sy no.22*/* of Jaddigadde village Hulekal Hobli Sirsi Taluk Uttara kannada District. In this location too after examination more than 15 residential houses and equal number of cattle sheds were found within the distance of 150 meters. Hence this alternative also could not be selected.
- c) Alternative 03: A fully stone covered area found in forest sy no.103 in Khurse village Sampakhanda Hobli Sirsi Taluk Uttara Kannada District. As we took a details survey and examination, it was found that the area was already proposed for stone quarrying proposal and it was submitted by a construction company which has got work of National Highway Project namely Up gradation of road from Kumta to Sirsi under Bharathamala Pariyojana phase-1 hence this location could not be selected.
