

As per Serial No. ix of the stipulated condition you have already deposited the Catchment Area Treatment Plan amount of Rs. 51, 25, 900/- (Rupees Fifty one lakh twenty five thousand nine hundred) only through e-portal on dated 06.08.2020 in the old wage rate @ Rs.286.30/-. In the mean while Govt. has enhanced the wage rate @ Rs.308/MD w.e.f. as per Notification No.6100 dated 21.10.2020 of the Labour Commissioner, Odisha. Now, the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act, O/o the Principal Chief Conservator of Forests, Odisha, Bhubaneswar has technically approved the Catchment Area Treatment Plan amount for Rs. 54, 48, 500/- as per wage rate of 308/MD with 10 year maintenance. The revised Catchment Area Treatment Plan is enclosed herewith for your ready reference.

It is therefore, requested to make the balance payment of Rs. 3, 22, 600/- i.e. (Rs. 5448500 - Rs. 5125900= Rs. 322600/-) through e-portal immediately and report the fact of deposit to the undersigned for taking further action at this end.




