The Gram Sabha of Naharup Gram Panchayat has given its formal consent to the proposal for diversion of forest land for construction of 33/11 KV sub-station with associated 33 KV line at Top Khongnangmakhong, Imphal East by taking a resolution to that effect in its meeting held on 31st January, 2018.

A copy of the resolution of the Gram Sabha in its meeting dated 31st January, 2018 is enclosed for reference.
