With reference to the above cited letter on the captioned subject, it is to inform you that the Government of India, Ministry of Environment, Forests & Climate Change, Eastern Regional Office, Chandrasekharapur, Bhubaneswar has accorded **Stage-I / in principle** approval for diversion of 03.94Ha. of Revenue forest land in favor of Odisha Power Transmission Corporation Ltd. for construction of 132 KV S/C transmission line from Boinda Grid Sub-Station to Railway Traction Sub-Station, Boinda, subject to fulfillment of 24 nos of conditions. In this context the State Govt. had imposed 12 nos of additional conditions for compliance by the User Agency.

(1) As per the stipulation **No-II** of the Stage-I approval orders, you are requested to deposit **Rs.24,66,440/-** (Twenty-Four Lakhs Sixty-Six Thousand Four Hundred Forty) only towards the cost of NPV in respect of Athmallik Forest Division as per the detailed calculation furnished below.

Calculation of NPV.

Density- **0.2** & Eco Value Class-**III**

Revenue Forest- 03.94Ha. X 6,26,000/- = **Rs.24,66,440/-**

(2) As per the stipulation **No-IV** of the Stage-I approval orders, you are requested to deposit **Rs.5,90,500/-** (Rupees Five Lakhs Ninety Thousand Five Hundred) only towards the cost of Compensatory Afforestation in respect of Athmallik Forest Division.

The said amount may please be deposited through the web portal in e-payment mode in Ad-hoc CAMPA funds in the Account Number **0371001010-25222** of Corporation Bank, Lodhi Complex Branch, Ground floor, Block No-11, CGO-Complex Phase-I, Lodhi Road, New Delhi -110003. The web portal receipt in support of payment should be submitted to this office for reference and record. Further you are requested to supply Division GIS cell related equipments worth Rs.3,00,000/- as discussed.

(3) As per the stipulation **No-X** of the Stage-I approval orders, you are requested to submit an undertaking to comply any further requirements/payments to be made as against the Violation reported under FC Act-1980 while processing of diversion proposal after a decision in this regard is taken by the Competent Authority.

(4) As per the stipulation **No-XIII** of the Stage-I approval orders, you are requested to prepare and submit a detailed scheme for creation and maintenance of dwarf species plantation (preferably zyziphus species) in Right of Way under the transmission line.

(5) As per the additional condition **No-12** imposed by the State Government, you are requested to prepare and submit a detailed scheme for Site Specific Wildlife Conservation Plan for protection of wildlife and conservation of their habitats.

On receipt of all aforesaid statutory levies, necessary follow-up action will be taken in compliance to order of State Govt. in F&E Department communicated vide memo no.17194/F&E Dt.28.09.2015 for allowing you to undertake project activities on Forest land, being diverted, for a period of one year pending grant and receipt of Stage-II forest clearance in favour of the project.


Further you are requested to submit point-wise compliance to the 24 conditions as per the Stage-I approval order of MoEF & CC, GoI and 12 conditions imposed by the State Government to this office for onward transmission to appropriate higher quarters at this end.
