

1	Legal Status of the forest land Shall remain unchanged.	
2	Compensatory afforestation shall be taken up by the Forest Department for plantation of 100 trees along, Rampur-Kemeri Road, Milak Range. District Rampur at the cost of the User Agency ,As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.	
3	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.	
4	The State Government shall charge the Net Present Value (NPV) for the 0.052 ha. forest area to diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No.566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letter No.5-1/1998-FC dated 03/10/2007-FC dated 05/02/2009 in this regard.	
5	Additional amount of NPV of the Diverted forest land, if any becoming due after	

	finalization of the same by the Hon,ble Supreme Court of the India on receipt of the report from the expert Committee shall be charged by the State Government from the User Agency. The User Agency shall furnish an and undertaking to this effect.	
6	The Geo tag images of the proposed CA land provided by the concerned DFO.	
7	Greenery will be maintained by user agency around Periphery of petrol pump.	
8	The complete compliance of the FRA, 2006 be ensured by way of prescribed certificate from the concerned District Collector.	
9	User agency shall use the land between entry and exit of petrol pump for plantation and conservation of trees ,the same shall be demarcated by 2 feet wall.	
10	Plantation shall also be done along the inside boundary of fuel Station.	
11	No violation of FCA certificate from concerned DFO shall be provided.	
12	Certificate of DFO certifying that the proposed RO is not in close proximity of any existing RO in accordance with MORTH guidance dated 24-07-2013 has to be provided.	
13	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.	
14	Period of diversion shall be co-terminus with period of lease to be granted in favour of user agency or the project life, whichever is less.	
15	Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation ,protection and development of forests & wildlife.	
16	All the Funds received from the user Agency Under the the Project shall be transferred /Deposit to Campa Fund only though e-portal (https://parivesh.nic.in/).	
17	The compliance report shall be uploaded on e-portal (https // parivesh .nic.in).
