Subject: Diversion of 0.3695 ha Protected Forest land of Roadside for laying 12" Dia Natural Gas Pipeline from Eklahare (Guj) to M/s. Reliance Industries Ltd., Kharadpada in the U.T. of Dadra & Nagar Haveli, Silvassa in favour of Gujarat State Petronet Limited, Gandhinagar.

Sir,

As per the power conferred under Order F. No. 11-9/98-FC dated 07.11.2014 by the Ministry of Environment and Forests, New Delhi the request of the Gujarat State Petronet Limited, Gandhinagar, Gujarat for diversion of 0.3695 ha. of Protected Forest land for laying of underground Natural Gas Pipeline from Eklahare (Guj) to M/s. Reliance Industries Ltd., Kharadpada in the the U.T. of Dadra & Nagar Haveli is considered and In-principle approval is accorded subject to the following conditions:-

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.
- ii No felling of tree shall be involved in the implementation of the proposal.
- iii The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.
- iv The pipeline shall be along the road within existing right of way not falling in National parks and Wildlife sanctuaries.
- v Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years.. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest department.
- vi The User agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.
- vii Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

- viii The User agency shall seek permission from local Forest Department for carrying out any maintenance;
- ix The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
- x The User Agency shall obtain the Environmental Clearance before issue the formal order.
- xi All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.
- xii All the fund received from the User Agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank A/c. No. SB01025204 (CAF D&NH) in Corporation Bank, Lodhi Complex New Delhi - 110003.
- xiii The forest land shall not be used for any purpose other than that specified in the proposal.

The Compensatory Afforestation and Net Present Value (NPV) estimated by Forest Department is ₹ 12,35,952/- (Rupees: Twelve Lakh Thirty Five Thousand Nine Hundred Fifty Two only).

You are therefore, requested to deposit ₹ 12,35,952/- (Rupees: Twelve Lakh Thirty Five Thousand Nine Hundred Fifty Two only) in favour of through RTGS/NEFT mode in the below mentioned account and copy of proof /evidence may be submitted to this office:-
