- (i) Short narrative of the proposal and project/ scheme for which the forest land is required.

The name of the project is "Rural connectivity road (RCR) from Tinkitam Road to Rayong Sardong". This will be a very important road and will be the life line of people residing this area. This road is 3.80 Kilometer long and connects villages like Tinkitam, Rayong Sardong etc. The entire village depends upon agricultural produce to run their livelihood. There is no road connectivity for these villages and hence the Government has decided to connect these villages by providing/constructing a rural connectivity road funded by PMGSY and has been sanctioned by the concern Ministry.
