The road Indalwai –Bheemgal is identified as Major District road. This road starts at Km.0/0 near Indalwai, on NH-44 road at Km 348/6-8, which is identified as one of the high density traffic corridor under major district roads category and ends at km.38/5, having a total length of 38.50 kms. The entire road is having black topped surface. As per the road statistics the total length of the road is 38.50 kms. i.e, Double lane from Km. 0/0 to 8/5, Single Lane from Km.8/5 to 38/5.

This road is being used by the people from three Mandals Viz., Dharpally, Sirikonda and Bheemgal. There are number of auxiliary roads connected to Indalwai-Bheemgal road. The villages connected to this road are Indalwai, Yellareddypally, Ansanpally., in addition to number of hamlets and villages are located on this road.

This road provides better route for the formers to transport their agriculture products to markets at Nizamabad. There is a famous pilgrim centre of Lord Laxmi Narasimha swamy located on "Limbadri Gutta" at Bheemgal

The road is passing through forest reaches from Km.9/0 to 11/4 both sides, The above forest reach is under the forest jurisdiction of Kamareddy Division.

Vide reference 1<sup>st</sup> cited above the Government of Andhra Pradesh accorded administrative sanction for Rs.10.00 crores for the work of "Strengthening and widening of Indalwai-Bheemgal road from km 0/0 to 38/5 in Nizamabad District "under CRF vide job No.CRF-AP-2014-816.

Vide reference 2<sup>nd</sup> cited above the work was entrusted M/s K.Yellaiah and Sons ,Nizamabad. The work completed in all reaches except from **Km 9/0 to Km 11/4** which is passing through the reserve forest area. The nature of the work is to convert the existing single lane (3.66m) width BT road to double lane (7.00 m) road width

It is proposed to take up road construction along the existing road. As such the permission of the forest authorities is required. Hence proposal is submitted for diversion of forest land worked out to an extent of 1.29 hectares in Kamareddy division.

A detailed Differential Global Position Survey is carried out in the above reach along with the forest section officers. As per our requirement the total extent of forest land is arrived at as 1.29 Ha in Jurisdiction of Kamareddy forest division, for which linear diversion of forest land is required.

The proposals are submitted as per the guide lines issued under forest (conservation0) Act 1980, the project for road construction will be processed in their entirety. Hence the proposals for acquisition of forest land is prepared in the Kamareddy forest Division in the prescribed format, drawing showing the cross section along with forest map showing the area of land herewith enclosed kind perusal. Hence I herewith submit the proposals under Forest (Conservation) Act, 1980 with the following enclosures.

Vide reference 4<sup>th</sup> cited above, ETS & DGPS /GNSS survey data, of the forest land proposed for diversion for this project furnished by us has been verified and accepted.

It is therefore requested the Principal Chief Conservator of Forests, Aranya Bhavan Hyderabad, Kindly initiate the process of Forest Land Acquisition and also requested to instruct concerned.
