In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers Recognition of Forest Rights) Act. 2006 (FRA, For short) on the forest land proposed to be diverted for non-forest purpose, it is certified that **47.763 Ha.** of forest land consisting of Amirganj & Chatarkota village proposed to be diverted in favour of Water Resources Division, Sehore (name of user agency) for Construction of **Mahadev Bendra minor Irrigation Project** which is situated in **Amirganj Village Tehsil Nasrullaganj District Sehore.**

- (bb) The discussion and decision of such proposal had taken place when there was quorum of minimum 50% of the members of Gram sabha present;
- (cc) The diversion of forest land for facilities managed by the Government as required under section. (2) of the FRA have been completed and the Grama Sabhas have given their consent to it;
- (dd) The rights of Primitive Tribal groups and pre-Agricultural Communities, where applicable have been specifically safe guarded as per section 3(1) (e) of the FRA.
