Subject: Proposal for diversion of 6.552 ha of forest land for construction of Moreh bypass from NH-102 near Indo- Myanmar Border to Land Custom Port of India to bypass Moreh Town, Manipur.

With reference to the subject cited above I am to say that the Ministry of Environment, Forests & Climate Change, North Eastern Regional Office, Shillong has accorded "In Principal Approval" for diversion of 6.552 ha of forest land for construction of Moreh bypass from NH-102 near Indo- Myanmar Border to Land Custom Port of India to bypass Moreh Town, Manipur. vide their letter F. No.3 MN C 054/2018-SHI/3388-89 dated 10th January, 2019(copy enclosed) and to inform you to deposit the following mandatory levies to Ad-hoc CAMPA Fund (CAF in New SB account No. 520101263743620 of Corporation Bank, CGO Complex, Phase-I Lodhi Road , New Delhi- 110003).

Further cost estimates for (i) demarcation of the land proposed for diversion,(ii) erection of cement-concrete boundary pillars and (iii) felling, logging and transportation of project affected trees will be submitted in due course for depositing to the account of the concerned Divisional Forest Officer in compliance with conditions laid down in the approval so that necessary working permission can be issued at the earliest.
