Incompliance of the Ministry of Environment and Forests (MoEF), Government of India letter No. 11-9/98-FC (pt) dated 3rd August 2009 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that Khasra No. 2586/352 area 20.5354 Ha., Khasra No. 670 area 12.5713 Ha., Khasra no. 972 area 1.7245 Ha. and Khasra No. 974 area 0.3626 Ha. total area **35.1938 ha.** of Jhar-Jankhar forest in Village **Jasrapur Tehsil Khetri, District. Jhunjhunu** proposed to be diverted in favour of General Manager, Power grid Khetri transmission system limited Khetri for the Construction of 765/400Kv Sub Station at Village Jasrapur Tehsil-Khetri District-Jhunjhunu Under Transmission System Associates with LTA Applications for Rajasthan Solar Enrgy Zone, Part-C

It is further certified that:

- (a) The complete process for identification and settlement of Rights under the FRA has been carried out for the entire **35.1938 ha.** of Jhar-Jankhar forest proposed for diversion. A copy of records of all consultation and meeting of the Forest rights committee(s). Gram sabha(s), Sub-Division level Committee(s) and the District level committee are enclosed annexure-I to annexure-III (Exempted vide MoEF's circular ref F. No: 11-9/98 - FC (pt) dtd: 05-09-2013)
- (b) the Proposal for such diversion have been placed before each concerned Gram Sabha of forest dwellers, who are eligible under the FRA; annexure-I (Exempted vide MoEF's circular ref F. No: 11-9/98 - FC (pt) dtd: 05-09-2013)
- (c) concerned Gram Sabha(s), has certified all formalities/processes under the FRA have been carried out and that they have given their consent to the proposed diversion and the compensation ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha of Jasrapur, Khetri, Jhunjhunu Village(s) is enclosed as annexure-I.
- (d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50 % of the members of Gram Sabha present.
- (e) the diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- (f) the rights of Primitive Tribal Groups and Pre-Agricultural Committees, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.

उप खण्ड अधिकारी खेतड़ी के पत्र क्रमांक विविध / 19 / 739 दिनांक 23/12/2019 के द्वारा ग्राम पंचायत जसरापुर अधीन ग्राम जसरापुर में राजस्व अभिलेख के खसरा नं. 670 मिन, 972 मिन, 974 मिन, 2586/352 मिन भूमी में से पावरग्रिड खेतड़ी ट्रांसमिशन सिस्टम लिमिटेड को 765 / 400 केवी उपकेन्द्र निर्माण हेतु 35.1938 हैक्टेयर भूमि के लिए एफ.आर.ए. प्रमाण पत्र का प्रस्ताव प्राप्त हुआ जिस पर आगे की कार्यवाही के लिए उक्त बैठक आहूत की गई ।

उपखण्ड अधिकारी खेतड़ी जिला झुन्झुनू की अध्यक्षता में हुई बैठक कार्यवाही विवरण दिनांक 23/12/2019, सरपंच ग्राम पंचायत जसरापुर की रिपोर्ट पत्रांक 89 दिनांक 20/12/2019 और विशेष ग्राम सभा जसरापुर दिनांक 20/12/2019 की रिपोर्ट के अनुसार डाइवर्जन हेतु प्रस्थावित भूमि पर अनुसूचित जनजाति एवं अन्य परम्परागत वन निवासी (वन अधिकारों की मान्यता) अधिनियम 2006, नियम 2008 तथा संशोधित नियम 2012 के अन्तर्गत परिभाषित कोई भी अनुसूचित जनजाति व अन्य परम्परागत वन निवासी का व्यक्ति / समुदाय उक्त अधिनियम / नियमों के अन्तर्गत किसी भी प्रकार के वन अधिकारो हेतु उपरोक्त अधिनियम एवं नियम में उल्लेखित पात्रता से संबंधित व्यक्ति निवास नहीं कर रहा है और ना ही इस प्रकार का कोई आवेदन लम्बित है ।


अतः पावरग्रिड खेतड़ी ट्रांसमिशन सिस्टम लिमिटेड को 765 / 400 केवी उपकेन्द्र निर्माण हेतु एफ.आर.ए. प्रमाण पत्र जारी करने का निर्णय लिया गया ।
