Sir,

In the context of subject and reference mentioned above, out of 896.83 Acres of non-forest land offered for CA (for compensatory afforestation scheme in connection with diversion of Barjora (North) Coal Mine project of WBPDC), a total of 245.66 Acres (99.41 ha) of non-forest land is verified suitable as per field reports from respective DFOs (copies enclosed).

The status as per DFO reports is tabulated, and is the current report during June 2022.

Encroached land or land only fit for grassland or flooded land cannot be accepted for CA. CA land cannot be accepted in parcels, fragments which will be difficult to maintain as tree plantations in future. Plots adjacent to existing forest land where trees may be planted, may therefore, be explored for CA land.

It may please be noted that unit of land area in Parivesh Portal for grant of Forest Clearance under Forest Conservation Act is Hectares (ha.) and not Acres. Please submit reports only in ha to avoid confusion.

Your memo No.COVC06110002/169 dated 22.6.2022 received today is under examination for suitability report.

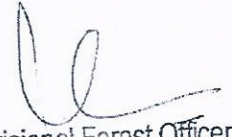
