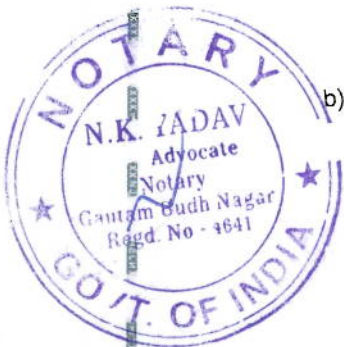

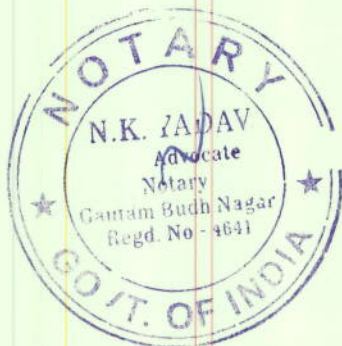
NOW KNOW YE AND THESE PRESENTS WITNESS that we, Essar Oil Limited do hereby appoint, nominate and constitute:

to be our true and lawful Attorney, for us in our name and on our behalf, to do all or any of the following acts, deeds and things :

1. To enter into Lease Deed in connection with acquiring properties in the state of Punjab on lease for setting up of the said retail outlets and for that purpose to execute lease deeds and leave & license including deeds of confirmation, that may be required in that regard, in such manner and on such terms and conditions as may be decided by the Company.
2. 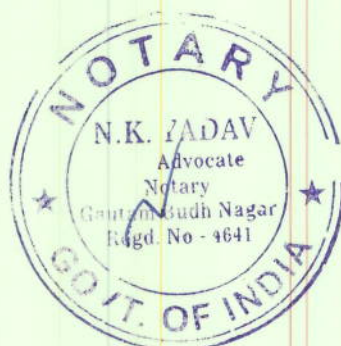
