It is to inform that vide reference 3<sup>rd</sup> cited above, the Government of India, MoEF&CC has accorded, Stage –I (in-principle) approval for Diversion of 1.8571 Ha Forest Land for Construction of 4 Lane access controlled New Green field Highway Station of NH 365 BG KMM Devarapalli of Length 33.644 from Thallampadu (V) to Somavaram (V) passing through the Velugumatla RF for a length of 309.52 Mtrs. in Compt No. 40 of Khammam Forest Division in favour of PD, PIU, NHAI, Khammam, subject to certain conditions stipulated therein, which has been communicated by PCCF(HoFF) in ref 4<sup>th</sup> cited and directed to issue demand notice in consultation with the Nodal Officer (FCA) to the user agency for making compensatory levies; to obtain the compliance report on conditions stipulated and furnish the same through CF, Khammam for obtaining Stage II (final) approval.

Accordingly, the demand notice prepared and approved by the Nodal Officer, (FCA), the user agency i.e. The Project Director, National Highways Authority of India, Project Implement Unit, Khammam. Therefore, it is requested to make the payments of compensatory levies like the Cost towards Raising and maintenance of Compensatory Afforestation land /Net present value (NPV) amount etc for **Rs 46,62,545/-**

(Rupees Forty six lakhs sixty two thousand five hundred and forty five only) into ADHOC CAMPA Account of Telangana through e-payment portal, by uploading the demand notice at <http://parivesh.nic.in> and generating the challan. **The payment to be made against the Challan number and the Challan is valid for one week.** **A step-by-step process is available** at <http://parivesh.nic.in>. The details of payments to be made by UA is as follows:

Further, the User Agency is requested to comply with the following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

- Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the UA is requested to furnish the undertakings for conditions (i), (vi), (vii), (viii), (ix), (x), (xi), (xii), (xiii), (xiv), (xv), (xvi), (xvii), (xviii), (xix), (xx) and note the other conditions strictly as per the plan prepared by the forest department.

Further, the User Agency shall pay the compensation to the eligible holders of RoFR title deeds settled as per the provisions of the LARR Act,2013 (C.No.xiii).

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission (for tree felling and execution of linear projects).

The User Agency is informed that for issual of working permission by the competent authority only when all such other compensatory levies specified in the Stage-I (in-principle) approval are realized from the UA including transfer and mutation of CA lands identified in the name of the forest department in case CA lands are to be handed over.

In view of the above, the User Agency, the Project Director, National Highways Authority of India, Project Implement Unit, Khammam is requested to make necessary payments in ADHOC CAMPA Account and CA PD Account of the Forest Divisional Officer, Khammam by generating e-challan and report compliance along with the condition wise compliance report of Stage – I Conditions for onward submission to the Prl. Chief Conservator of Forests (HoFF), TS, Hyderabad (FCA) for getting Stage – II and final approval.
