You are hereby requested to upload this demand notice for Rs: 47,44,089 (Forty Seven Lakh Forty Four Thousand and Eighty Nine Only) under CAMPA account in Government of India web portal www.parivesh.nic.in on acceptance of the demand notice by the Nodal officer. payment may be made by generating challan in parivesh web portal and Rs: 3,39,011 (Three Lakh Thirty Nine Thousand and Eleven Only) Demand Draft from Nationalized Bank under the name of The Deputy Conservator of Forests, Dharwad Division, Dharwad., to be made which will be remitted under Afforestation Head (HoA: 0406-01-800-0-08).

Regarding felling of trees you are hereby directed to restrict the felling of trees to minimum number. An under-taking to be given by the User Agency for payment of felling of trees before stage-II clearence. User Agency will follow due diligence in designing stage to minimise number of trees required to be felled. Due process of law will be followed for tree cutting in the diverted forest land and the tree shall be felled under the strict supervision of the State Forest Department and the cost of felling trees shall be deposited by the User Agency with the State Forest Department.

Further, It is informed that if any payment is made by any other method, the same shall not be considered for compliance towards stage I/II, it is also requested to submit the receipt along with the condition wise compliance report as per the stipulated conditions in the stage I approval given vide reference (1) for further action.
