With reference to the above subject, the Ministry of Environment Forests and Climate Change, Bengaluru has accorded 'in principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for diversion of 4.85 ha of forest land in North Eastern Block (NEB) Forest (near Karadikolla Village), Sandur Taluk, Ballari District for approach road to mining lease No.2487 (an e-auctioned C-category mine of erstwhile FC holder M/s. Laksmi Narayana Mining Company) in favour of the successful bidder i.e. M/s.MSPL Ltd, Hospete vide letter under Ref(1).

The Principal Chief Conservator of Forests, (Forest Conservation), Bengaluru has directed you to make payments (Net Present Value, CA and other charges) through e-payment module as per the Demand notice from office of the undersigned as per conditions stipulated in the Stage-I approval accorded by the Government of India vide letter dated:24.05.2021 for the proposal for diversion of 4.85 ha of forest land in North Eastern Block (NEB) Forest (near Karadikolla Village), Sandur Taluk, Ballari District for approach road to mining lease No.2487 (an e-auctioned C-category mine of erstwhile FC holder M/s. Laksmi Narayana Mining Company) in favour of the successful bidder i.e. M/s.MSPL Ltd, Hospete. In this regard, the office of the undersigned had issued demand notice vide letter under Ref(4). But, you have not remitted the charges till now.

Further, you have requested the undersigned to confirm the total amount to be paid as per demand notice issued by this office vide under Ref(5). In this regard, it is observed that, there is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) for the year 2022-23] notified vide letter under Ref(3). Further, it is directed once again to upload Condition-wise Compliance Report in respect of all the conditions stipulated in Stage-I approval on web portal and submit the ink-signed hard copies (minimum 7 sets) through the Comptent Authority for further processing.
