

- Adverting to the subject and references died, it is submitted that, the Government of India, MOEF&CC, IRO, Myderabad vide reference 11thcited, has accorded in-principle (Stage-I) approval for diversion of 1.1509 ha of forest land for construction of permanent helipad adjoining Potts Sir Ramulu Telugu Vishwa Vidyalayam university and District Collectorate office in National district in favor of Engineer in Chief (R &B) NH Buildings & CRF, Errumanzil, Hyderabad (User Agency), which has been communicated in ref 12th cited to raise the demand notice over the user agency in consultation with Nodal Officer, FCA for making payment of compensatory levies and to obtain the compliance report on stage-I approval from the user agency and furnish through Chief Conservator of Forests/ Field Director, Amrabad Tiger Reserve, Achimpaet to obtain the final (Stgae-II) approval from the GoI.
- In view of the above, the User Agency will be requested to deposit the following payments towards cost of NPU. CA and other charges as shown below:

B) Further, the User Agency has to deposit the following amounts estimated towards the cost of construction of boundary pillars along the length of the forest area proposed for diversion and estimated cost of extraction of tree growth in the account of Forest Divisional Officer, Nalgonda IDBI,Nalgonda, Opp. MRO Office R.P. Road, Nalgonda (A/c No 1128104000067150, IFSC Code :IBKL0001128.

- c) The User Agency (UA) will be informed that as per the guidelines issued by MoEF&CC, Gol the mode of remittance for compensatory levies shall be through e-payment portal of Ministry of Environment, Forest & Climate Change only. The User Agency has to upload the demand notice received in the Ministry's portal at https://parivesh.nic.in/: against the project for approval by the Nodal Officer, FCA, Telangana State. After approval of demand notice, then challan has to be generated and payment to be made against the bank account number indicated in the challan. Amount deposited through other mode will not be accepted. The detailed procedure for generation of Challan and deposition of funds is available at https://parivesh.nic.in portal.
- The UA shall comply with the following in accordance with the MoEF&CC, GoI instruction issued vide F.no.7-23-2012-FC, dt.24-07-2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, dt.23-08-2013:-
 - Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
 - ii. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.
- The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) Clearance from IRO, MoEF&CC, GoI and will be requested that no work in violation shall be carried out.
- Further the User Agency will be requested to transfer and mutate the non-forest CA land identified in favor of forest department
- The User Agency will be informed that this in-principal approval is valid for the period of (5) years. In the event of non-compliance of the above conditions, this in-principal approval shall automatically stand revoked after (5) years.
- 7. The UA will also be requested to note the other conditions stipulated and implemented and furnish the compliance on the conditions stipulated, along with the necessary undertakings on C.No.(i), (vi), (vii), (ix), (x), (xii) to (xx) and evidence of payment of compensatory levies to District Forest Officer, Nalgonda for submission through Chief Conservator of Forests/Conservator of Forests for anward submission to Government for obtaining Stage-II approval.

 In view of the above, the Principal Chief Conservator of Forests (Head of Forest Force) is requested to kindly accord permission to raise the demand notice over the User Agency.
