No.140, 120, 118, 118, & 118 of Manugur (S) (0.0018), Manugur (W) (0.0295), Manugur (W) (0.1062), Manugur (W) (0.0271), Manugur (W) (0.0191) respectively, Compt. No.111 of Kondaigudem (0.0248), Compt. No. 108 of Sambaigudem (0.492), Compt. No.30 & 29 of Janampeta (0.0747) & (0.0432) respectively, Compt.  - v. the User Agency to make good any loss to forests / environment,
 - vi. the User Agency should take permission for carrying out any maintenance, and,
 - vii. the User Agency should pay compensation for the felled & damaged trees, if any.

3. The Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad shall take necessary action, accordingly.
