The undersigned is pleased to convey the formal approval of the Government under section-2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.

3. The user Agency will have to obtain permission from this office for carrying maintenance works in future.
4. The user Agency will have to make good the forest land after use /maintenance. **No trees shall be cut.**
5. The user agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
6. The user Agency will seek permission from the Road & Building Department / Science and Technology Department, Sachivalaya, Gandhinagar.
7. The optical fiber cable line will be laid underground in a trench of depth of 1.65 Mtr. and width of 0.45 Mtr. in between rows of road side plantation.
8. Any other condition, which the Nodal office (FCA)/may stipulate from time to time.
