With reference to the above subject, the Government of the India, MoEF&CC, New Delhi has accorded Final / Stage-II approval (Forest Clearance) under the provisions of Section-2 of Forest (Conservation) Act, 1980 (vide File No. 8-17/2021-FC, Dt.10.07.2023), Government of Karnataka (vide Order No. FEE 16 FFM 2021, Bangalore Dt.18.07.2023) has ordered for diversion of 53.67 ha forest land (originally proposed for 75.92 ha) for Construction of Screening Plant, Tailing Dam, Slurry pipeline Corridor & Water Pipeline Corridor at Donimalai of M/s, National Minerals Development Corporation Limited, Donimalai, Sandur vide letter under Ref(1) & (2).

In the light of approval accorded by the Government of India and Government of Karnataka in their orders, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru (vide letter No. KFD/HOFF/A5-1/(MNG)/31/2019-FC Dt.10.08.2023) has directed the Deputy Conservator of Forests, Ballari to execute an Agreement with User Agency duly incorporating all the terms and conditions as imposed by the Government of India and Government of Karnataka and standard conditions applicable to FC leases from time to time and further subject to payment of any recoverable balance in compliance of the conditions of Stage-I & Stage-II (final) approvals vide letter under Ref(3).

Further, the User Agency was asked to submit the De-siltation plan as per the condition No. (viii) of Final / Stage-II approval. In this regard, the User Agency has identified water bodies falling 5 kms radius from the propose project site of SP-II and submitted the Detailed Project Report of Desiltation plan. The same has been submitted by the undersigned vide letter Dt.10.08.2023 under Ref(4).

Further to this, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has approved the Plan of De-silting of identified village tanks, water bodies and directed the undersigned to raise the demand notice for the same to the User Agency and also directed to take further necessary action for implementing the same vide letter Dt. 18.08.2023 under Ref(5).

Therefore, the details of amount to be remitted as plan approved for De-silting of the identified village tanks, water bodies is as under;
