In the 3rd reference cited, it is requested that the documents, under takings and details should be furnished to this office urgently for submitting compliance report to the Principal Chief Conservator of Forests (HoFF), Chennai.

In the 4th reference cited the demand to obtain the stage-II clearance is requested.



- a) An amount of Rs.1,75,231/- (Rupees One lakh Seventy Five thousand Two hundred and Thirty one only) may be deposited being the cost of Compensatory Afforestation (CA) over an area of 0.10 Ha (100 Nos) in the degraded Forest area of Adukkam Reserved Forest in Villupuram Range and the fact is reported to this office.
- b) An amount of RS.2, 07,743/- (Rupees Two lakhs Seven thousand Seven hundred and Forty three only) may be deposited being the Net Present Value (NPV) based on the Honourable supreme court of India.
