It is submitted that vide ref 1<sup>st</sup> cited, the MoEF& Climate Change Integrated Regional Office, Hyderabad has accorded in-principle (Stage-I) approval for Re-Diversion of 1.0003 Ha (Laying of UG electric cable ) and Division of 0.010 Ha (Construction of Tower) Totaling to 1.0103 Ha of forest land in Shamshabad division for laying of 220 KV XLPE UG cable for LILO of 220 KV Gachibowli to Erragadda and Miyapur to Raidurg SS and construction of CTT tower in Botanical Garden parking area in favour of Executive Engineer, 400 KV-I, Me / Const Metro circle, TS TRANSCO subject to certain conditions stipulated therein; which has been communicated in ref 2<sup>nd</sup> cited by the Principal Chief Conservator of Forests (HoFF) with instructions to raise the demand notice over the user agency for making payment of compensatory levies for deposition into respective accounts in consultation with the Nodal officer (FCA); and to obtain the compliance on the conditions stipulated from the user agency and furnish for onward submission to the Government for obtaining Stage I approval.

**Accordingly, the demand notice is prepared and furnished as follows:**

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F. No. F. No. 4-TSB182/2021-Hyderabad/96, Dt. 26.10.2021 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No. 14162/2019/FCA-4, Dt. 06.11.2021:

3. Publish the entire forest clearances granted in verbatim along with the condition and safeguards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
4. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the User Agency will be requested to furnish an undertaking that "the user agency shall erect display/ signage boards at appropriate places for safety and awareness as per the guidelines"

Further, the User Agency will be requested to furnish the compliance on the conditions stipulated in the Stage I (in-principle)approval along with all the required relevant information/documents etc. for onward submission to Government for obtaining Stage-II approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval / working permission and no work in violation shall be carried out.
