KSR Prince Hatcheries Ltd., Visakhapatnam.

I am to inform that the User Agency i.e.M/s. KSR Prince Hatcheries Ltd., Visakhapatnam, has furnished justification stating that KSR Prince Hatcheries Ltd., established Shrimp hatchery near Gudivada (V), S.Rayavaram (M), Visakhapatnam District. Since, their hatchery requires sea water and they have applied for laying PVC pipe line to draw sea water from Bay of Bengal to KSR Prince Hatcheries Ltd., through Gudivada Village RF situated in Sy.No.209 Katha No.1539 of Gudivada Village, S.Rayavaram Mandal, Visakhapatnam District passing through K. Polavaram forest block and there is no alternative way to lay the water pipe line from the Bay of Bengal. The User Agency has furnished undertakings for payment of NPV, Addl.NPV, cost of raising and maintenance of compensatory afforestation, cost of tree extraction charges and escalation charges etc. The District Collector, Visakhapatnam District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded in the Ministry's website and unique file No.FP/AP/Pipeline/41405/2019, has been generated for this proposal. The concerned Divisional Forest Officer, the Conservator of Forests and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively.
