With reference to the above subject, the undersigned has submitted the compliance report to conditions imposed in Stage-I approval with respect to diversion of 9.12 Ha (Revised from 9.40 Ha) Forest Land in Ramanamalai Block, Sandur North Range, for use of approach road in favour of M/s Zeenath Transport, Company, Bellary District vide letter under Ref(5).
