Immediate attention of the Sri G.Chandrasekhar Reddy, S/o G.Narasimha Reddy, and others of Mudimiyal Village, Chevella, Rangareddy District is invited to the subject and references cited above.

In the reference 4th cited, the proposal for diversion of **0.2038 Ha** of forest land in Mudimiyal RF of Shamshabad Division of Rangareddy District of Rangareddy Circle for formation of approach to reach agricultural lands from **Hyderabad to Vikarabad-Tandur** State High way in favour of G.Chandrasekhar Reddy, Rangareddy and others was forwarded to the FDO, Shamshabad/ DFO, RR & APCCF/CF, RR for processing under Forest (Conservation) Act, 1980 and amendments issued thereof.

In the reference 5th cited, the APCCF/ CCF, RR Circle has submitted a detailed report alongwith part-II of the FDO, Shamshabad and DFO, RR on the subject proposal and reported the following:

- 1) The forest area proposed for diversion is inspected by the FDO, Shamshabad on 10.08.2021 and observed that two alternate roads already exist to reach their agricultural lands, as detailed below:
 - a) From Mudimiyal Village road and along North-East side of boundary of RF comes to a length of 2.95 Km.
 - b) From Malkaram Village and along the boundary of North-West side of the boundary of RF comes to a length of 3.52 Km.
- 2) The DFO, RR has stated that the Mudimiyal RF block is already segregated into two parts by formation of Hyd-Vikarabad-Tandur State High Way which is passing through mid of Forest Block and even though the alternatives available, if the diversion proposal is accepted the RF block will be segregated into three parts and the proposed were not recommended / rejected in part-II.
- 3) Duly informing the above, the APCCF/ CF, RR has concluded that the application for diversion is not recommended / rejected as two alternative roads already existing.

In view of the above, the request made by the Sri G.Chandrasekhar Reddy, S/o G.Narasimha Reddy, and others of Mudimiyal Village, Chevella, Rangareddy District vide ref 3rd cited for diversion of forest land to an extent of 0.2038 Ha for the subject project is hereby **rejected/ not recommended**.

Sri G.Chandrasekhar Reddy, S/o G.Narasimha Reddy, and others of Mudimiyal Village, Chevella, Rangareddy District are further directed to ensure that no work in violation of the Forest (Conservation) Act, 1980 takes place in the forest area in question. If any violation is noticed, necessary action in accordance with the Rules will be taken against the officials responsible of the PR Dept as per the rules in vogue.

It is submitted that, vide reference 1st cited the Prl. Chief Conservator of Forests (HoFF), Telangana State, Hyderabad has forwarded the proposals for diversion of **0.2038 ha** of forest land in Mudimyal RF of Shamshabad Division of Rangareddy District of Rangareddy Circle for formation of approach road to reach agricultural lands from Hyderabad - Vikarabad - Tandur State Highway in favour of G. Chandrasekhar Reddy, Rangareddy and others and requested to process the proposals in light of guidelines issued under Forest Conservation Act and RoFR Act.

Accordingly, the District Forest Officer, Rangareddy has processed the proposals and submitted that the proposed area is falling in Mudimyal RF block which is notified U/s. 15 of A.P. Forest Act, 1967 vide A.P. Gazette No. 941, Dt: 12.05.1970 and also submitted that the Forest Divisional Officer, Shamshabad has inspected the proposed area on 10.08.2021 and test checked the geo-reference co-ordinates submitted through DGPS survey and found that the total length of the proposed diversion is 203.78 mtrs with a width of 10 mtrs involving (0.2038 ha) of forest land for diversion and found tallied and there is no tree growth extraction in the proposed area.

It is further submitted that during the inspection of the Forest Divisional Officer, Shamshabad it is observed that there are (2) alternative routes are existing to reach their agricultural lands as follows:

1. From Mudimyal village road and along North-East side of the boundary of RF comes to a length of 2.95 km.
2. From Malkaram village and along the boundary North-West side of the boundary of RF comes to a length of 3.52 km.

Further, the District Forest Officer, Rangareddy has stated that the Mudimyal RF block is already segregated into two parts by formation of Hyderabad - Vikarabad - Tandur State Highway through mid of Forest Block and even though the alternatives available if the diversion proposals is accepted the RF block will be segregated into three parts and the proposals were not recommended / rejected submitted in Part-II.

Therefore, based on the recommendations of the District Forest Officer, Rangareddy the proposals for diversion of **0.2038 ha** of forest land in Mudimyal RF of Shamshabad Division of Rangareddy District of Rangareddy Circle for formation of approach road to reach agricultural lands from Hyderabad - Vikarabad - Tandur State Highway in favour of G. Chandrasekhar Reddy, Rangareddy is hereby **Not Recommended / Rejected.**
