It is to inform that, the Government of India MoEF & CC RO, Hyderabad vide reference 1<sup>st</sup> cited has accord stage-I for diversion of 0.9717 Ha of forest land in Tumulur RF of Shamshabad Division for construction of approach road to reach the agricultural and farm lands from Srisailam Highway to Lemoor village in favour of Tumfor Agrifarms LLP, Shaikpet Nala. Further the Prl. Chief Conservator of Forests, (HoFF) TS Hyderabad vide reference 2<sup>nd</sup> cited has issued instructions to raise the demand with the user agency for payment of CA amount as per the scheme prepared.

In this regard, it is requested to deposit the following payment towards the cost of Compensatory Afforestation (CA) Scheme as shown below.

Further it is requested to hand over the Non Forest Land (NFL) under proper panchanama and also submit mutation /details entered in Dharani portal and other relevant documents etc., for taking further necessary action.

The map of the Non Forest Land (NFL) has to be attested by the concerned FRO, User agency and Revenue Department.

The user agency shall follow the Guidelines regarding deposition of compensatory levies into Adhoc CAMPA account as shown below:

The User Agency is directed to deposit the compensatory levies towards CA, NPV etc. into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account maintained in the Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003, through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., http://parivesh.nic.in by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at http://parivesh.nic.in.

Further it is also informed that, this in-principle approval shall be valid for a period of 2 years. In the event of non-compliance of the above conditions, this in-principle approval shall automatically stand revoked after 2 years. The user agency shall not execute the work in forest land proposed to be diverted till the approval is accorded to the proposal by the Central Government.
