Demand Notice for differential NPV charges

With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), New Delhi has accorded Stage-I / In-principal approval for Diversion of 4.74 hectare of forest land in DM Block, Sandur Taluk, Ballari District for use of existing approach road to MLNo. (0004) 2366 in favour of M/s. JSW Steel Limited, Toranagallu imposing certain conditions vide letter under Ref (1).

In this regard, office of the undersigned had submitted the compliance report to condition imposed in Stage-I approval and recently submitted EDS query sought by the Government of India vide letter under Ref(7).

Further, the Government of India, Ministry of Environment, Forest and Climate Change (Forest Conservation Division), New Delhi has issued clarification regarding applicability of revised rates of Net Present Value vide letter Dt. 22.03.2022 and stated that, *"The new rates will also be applicable on all the cases that were granted Stage-I / in-principal approval prior to 06.01.2022 and where even after lapse of 5 years, the Stage-II / Final approval is not granted due to non-submission of complete compliance of the conditions stipulated in Stage-I / in-principal approval"*.

Therefore, Stage-II / Final approval not yet granted for this proposal even after lapse of 5 years. Hence, the new rates of NPV are applicable for this instant proposal.

Hence, the differential of NPV charges as applicable for the above referred proposal are calculated as here under;
