With reference to the subject and references cited, it is informed that, the Government of India, Ministry of Environment & Forests, Regional Officer (C), IRO, Hyderabad in the reference 3rd cited, has accorded in principle (Stage-I) approval for diversion of 2.1004 Ha (1.4736 Ha in Asifabad Division & 0.6268 Ha in Bellampally Division) of forest land for laying of BT Road from R&B Road to Chinnagudipet Via Parvathipet in Dahegaon Mandal, Hathini RF of Asifabad and Bellampally divisions of KB Asifabad and Mancherial Districts respectively in favour of District Panchayat Raj Engineer, PIU, KB Asifabad. (User Agency) subject to compliance of certain conditions stipulated there in ; which has been communicated by the Prl.Chief Conservator of Forests TS Hyderabad vide reference 4th cited and requested the DFOs/FDOs to raise the demand note as per the actual rates and submit the demand note to the Nodal Officer for vetting. Further Principal Chief Conservator of Forests, TS Hyderabad has informed that only after vetting of the demand note by the Nodal officer, the District Forest Officer/Forest Divsional Officer should raise demand with the User Agency, who inturn has to upload the demand online on Ministry's portal, generate challan & transfer the funds through online only into the specified Ad-hoc CAMPA account of Telangana state. The detailed procedure for generation of Challan and deposition of funds is available at https://parivesh.nic.in.// portal.

Further the Principal Chief Conservator of Forests TS Hyderabad has informed that the mode of payment for compensatory levies shall be through e-payment portal of Ministry of Environment, Forest & climate change only as per the guidelines issued by MoEF &CC, Gol (Ad-hoc CAMPA)

Accordingly, the demand as approved by the Nodal Officer vide reference 5th cited above is raised as follows to make payment of various compensatory levies.

The User Agency shall deposit an amount of Rs.1,55,400/- (Rupees One Lakh Fifty five thousand four hundred only) in favour of Forest Divisional Officer, Bellampally PD A/c No.37110004892, IFSC Code SBIN0020120, State Bank of India, Branch Bellampally.

CA etc.into Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account through the Ministry's Website i.e., http://parivesh.nic.inby generating the challan in consultation with the Nodal Officer (FAC) O/o Principal Chief Conservator of Forests (HoFF), TS, Hyderabad. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at http://parivesh.nic.in. The details of funds to be deposited into Adhoc CAMPA Account of Telangana are as follows:

Further, the User Agency is requested to intimate the details of payments made and submit seven sets of compliance report on all the conditions stipulated in Stage-I approval along with all the necessary documents, certificates, undertaking etc., to the Forest Divisional Officer Bellampally for submitting the remarks on condition wise compliance report to this office for onwards submission to the competent authority for issue Stage-II approval.

The User Agency is requested to comply with the following accordance with the Government of India instructions issued vide F.No.7-23/2012-FC, Dt.24.07.2013 communicated vide PCCF's Re.No.45921/2001-F4, Dt.23.08.2013 and publish the orders at the cost of the project proponent.

Publish the entire forest clearance granted in verbatim along with the conditions and safe-guars
imposed by the Central Government in two widely circulated daily newspapers, one in
vernacular language and the other in English language, so as to make people aware of the
permission granted to the project proponent for use of forest land for non-forest purpose.

- The copies of the Forest Clearance should also be submitted to the Head of local bodies.
 Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices
 of the Government who in turn has to display the same in 30 days from the date of receipt of
 this reference.
- The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

In view of the above, the User Agency i.e District Panchayath Raj Engineer, KB Asifabad District is requested to submit the compliance report as per the above for taking further course of action in the matter.
