No.20/21/2015-For and Envt: In Pursuance of the letter No. 7-129/2015 -Forests dated 19-6-2015, of Ministry of Environment, Forest and Climate Change, Govt. of India, New Delhi, the Governor of Manipur is pleased to accord general approval of (Stage-I) under section-2 of the Forest (conservation) Act, 1980 for the diversion of 0.1318 hectares of forest land for construction of RCC tunnel for conveyance of water along the right main canal of Dolaithabi Project, Manipur subject to the following conditions:-

Legal status of the forest land as Reserved Forest shall remain unchanged.

No tree felling is allowed in the diverted forest area other than those proposed by User ii. Agency in their Application under Section-2 of FC Act, 1980.

The requirement of forest land for the proposal shall not exceed the barest minimum duly iii.

certified by the concerned Divisional Forest Officer.

The Nodal Officer, FCA, Manipur shall submit monthly report to the Ministry of iv. Environment, Forest and Climate Change, North Eastern Regional Office, Shillong by 5th of every month regularly regarding the conditions stipulated in general approval to this proposal.

Indigenous tree species numbering one hundred shall be planted by User Agency in consultation with the DFO, Central Forest Divission in the vicinity and the planted trees

shall belong to the State Forest Department.

User Agency shall be responsible for any loss to the flora/fauna in the surroundings and vi. therefore shall take all possible measures to conserve the same.

User Agency shall deposit the amount of NPV/Addl.NPV as stipulated by the vii. MoEF/Hon'ble Supreme Court from time to time.

The General Approval granted by the State Government shall be subject to the monitoring viii. by the North Eastern Regional Office, MoEF &CC, Government of India, Shillong.

The forest land shall not be used for any purpose other than that is specified in the ix. proposal. Any changes in the land use without prior permission of the Central Government shall amount to the violation of Forest (Conservation) Act, 1980.

The State Forest Department/ State Government or the North Eastern Regional Office MoEF &CC, Government of India, Shillong may impose from time to time any other condition in the interest of Conservation/Protection and/or development of forest.

ROFR certificate issued by ADC/Kangpokpi should be addressed to the DFO concerned or xii.

the Nodal Officer specifically.

Further, proposed forest land should not be handed-over to User Agency until such time, xiii. the compliance report in full is submitted to Administrative Department in Government through proper channel and the Stage-II(final) clearance issued by Government.
