



I am directed to refer to State Government's letter No. FEE 39 FFM 2019 (e) dated Sir, 14/06/2021 and 21/10/2021 on the above mentioned subject. In this regard, it is informed that the proposal for change in land use pattern for existing FC approved area for 2.02 ha. has been considered and after careful consideration of the proposal, approval of Central Government is hereby accorded for change in land use pattern as under:-

The aforesaid approval is subject to the following conditions:-

(1) Only minimum area should be utilized for internal roads.

- (2) No felling of existing trees shall be carried out except in unavoidable circumstance with the prior permission of the State Forest Department.
- (3) Open space shall be planted and maintained by the User Agency with indigenous species of trees.
- (4) The User Agency will obtain necessary permission and registration from the Competent Authority before starting the medical establishment.
- (5) If the land is not put to use within two years for the above purpose, this approval will be revoked.

Further, it may also be noted that the other conditions stipulated in the Stage-II approval letter No.F(C)A/11.2/193/KAR/BC/49 dated 13/04/2016 shall remain unchanged.
